## Message from the Chair

Dear WFIS Members and Constituents,

I write to you today to announce that Washington Federation of Independent Schools' Executive Director Judy Jennings will be retiring in June 2011. I share this news with a sense of accomplishment in all that WFIS has achieved in the past six years under Judy's leadership, as well as optimism and excitement for the future of the organization.

It is almost impossible to fully describe and appreciate the depth and breadth of the work that Judy has done for WFIS and for all private schools in Washington State. For those of you who have been lucky enough to meet her in person, you know that she is a force with which to be reckoned and that her passion and belief in the need for independent, non-public education drives her work state-wide.

I would like to highlight just a few of the milestones reached by WFIS under Judy's leadership:

- State Board of Education (SBE) recognizes private school accrediting agencies
- Private schools representative with full voting privileges added to the SBE
- WFIS appointee included on the Early Learning Council
- Private schools exempted from standardized sex education and HPV education laws
- Private school input for health and safety rules for all schools
- In collaboration with the Council for American Private Education, private school teachers included in federal loan forgiveness program
- Legislation to allow private schools access to FBI background checks
- The first Title II statewide conference offered, free of charge, to all private school teachers

Dear Member Schools, Colleagues and Friends of WFIS,

In 1967 I was handed my first teaching contract in the Puyallup School District. The day I walked into my first 7th grade class, I was hooked on teaching and on education. The journey of 44 years as an educator has taken many forms: Department Chair, union representative, private school teacher, WIAA and NFHS board member, private school principal, superintendent, WFIS legislative committee member, and most recently lobbyist and Executive Director for WFIS. As I look back over the years, I am profoundly grateful to all of my mentors, friends and colleagues who have influenced my passion for seeing that all children should have the opportunity for a world-class education. I believe that can be accomplished with a minimum (or less) of government support or intrusion. I have been blessed by the support of every board member that I have had the privilege to work and learn from. I believe that, right now, WFIS is in a very strong position. We are a well-respected and influential organization within our state and nation.

## The Rise of AdvancED

In an paper dated November 9, 2009 and entitled *The*

strategic development between the many different constituencies. WFIS schools are affiliates of the Catholic dioceses in the state; the Association of Christian Schools International (ACSI); the Christian Schools International (CSI); Lutheran Schools; Montessori schools; the Pacific Northwest Association of Independent Schools (PNAIS); the Seventh-day Adventist Schools (SDA); and numerous other religious and independent institutions, including the Waldorf Schools, Hutterian Brethren, and those institutions with sponsorship within the Jewish and Islamic communities. The WFIS Board of Directors consists of eighteen school heads representing the major constituencies chosen regionally by their respective bodies. WFIS is networked with similar organizations in other states through the Council for American Private Education (CAPE).

*Rise of AdvancED and the Potential Impact upon Private Schools*, Meade Thayer, Executive Director of the Pacific Northwest Association of Independent Schools, sounded the alarm that AdvancED was changing the accreditation landscape across our nation. The article was very informative, and I urge all member schools to study the issue of regional accreditation with their school accreditation teams and within their statewide associations.

AdvancED has recently moved to sign a Memorandum of Understanding with the Association of Christian Schools International (ACSI) and a completely separate agreement with Christian Schools International (CSI). Rumor on the street is that AdvancED will be attempting similar exclusive relationships with more of these types of nation-wide associations. The exclusivity is further demonstrated with the addition of a Confidentiality and Non-Disclosure Agreement that makes it even more difficult to share information and discussions on best practices among schools that are not in the same associations.

I understand the allure that AdvancED holds for many of our nation-wide associations. They also represent schools in states where AdvancED holds the keys to funding that non-public schools in Washington state cannot access. The accrediting agency in some of these states lends integrity to diplomas and transcripts for non-public schools. For many schools, AdvancED is the only game in town. For those schools and in those states, AdvancED offers a meaningful and viable avenue to accreditation, but Washington is not one of those states.

The Washington Federation of Independent Schools (WFIS) has fought long and hard to bind us together so that we can celebrate our independence. Our diversity has been consolidated to improve student learning in the state of Washington through the work of groups like the Private School Advisory Committee (PSAC) and the Northwest Accreditation Commission (NWAC). This has manifested itself further in the recent teacher training opportunities held in Seattle and Spokane last June. Allowing AdvancED to dictate who we can talk to about something as important as accreditation flies in the face of everything we have been attempting to accomplish.

I encourage you to talk with your regional and national associations about AdvancED. At the same time, continue to act on the commitment that we in the state of Washington have made to improve student learning by encouraging dialogue of improving student learning within the various schools that provide parents with choice.

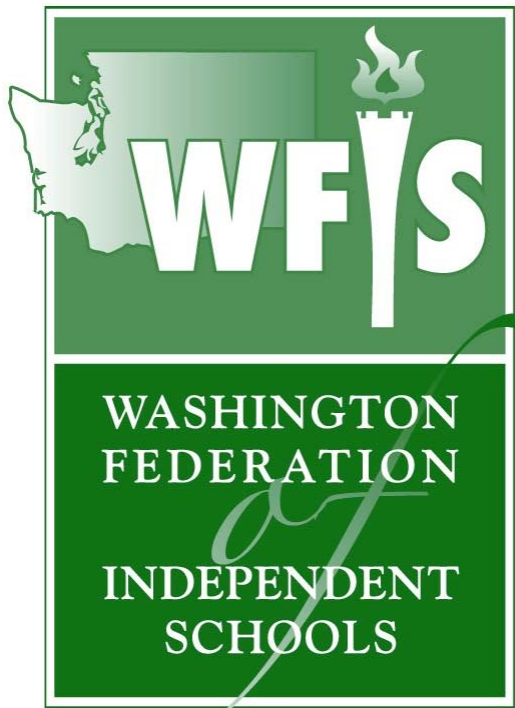
